DIRECTIONS: Closest address is the Lake Moomaw Marina Store at 8446 Bolars Draft Road, Hot Springs, VA 24445. From Warm Springs, take SR 39 west for 11.4 miles. Turn left onto SR 600 (Bolars Draft Road) and proceed for 7.8 miles. Pass turn for campgrounds (Twin Ridge Drive) and continue past the marina for 2.5 miles towards north end of the lake. Turn right at the McClintic Point sign.

FACILITIES: There are 3 group campsites, group fire rings and cooking grills, picnic tables and vault toilets.

Reservations required: Call 1-877-444-6777 or visit www.recreation.gov to make reservations.

OPPORTUNITIES: Away from the developed camping sites at Bolar Mountain, McClintic Point offers a primitive and peaceful setting for group camping. Fire pits, open fields, a horseshoe pit and abundant wildlife make this a special area to visit. In the campground there is an old barn bridge from the McClintic family homesite. Nearby are reminiscents of other settlers, including spring fields of daffodils and old apple trees.

Hikers: The Bolar Loop Trail is a pleasant hike near Lake Moomaw. Points along the ridgeline offer views of Lake Moomaw below. This trail can also be accessed by the Campground Spur Trail and the Fee Booth Spur Trail.

Bolar Loop Trail is 2.10 miles in length. The Bolar Loop Trail is moderate difficulty. Trail use is limited exclusively to foot traffic.

Anglers: Lake Moomaw is a great place to fish for Brown & Rainbow Trout, Crappie, Chain Pickerel, Yellow Perch, Small & Large Mouth Bass, Bluegill & Catfish. Follow all Virginia and Forest Service license regulations for the area.

Boaters may use the Bolar Flats Marina.

NEARBY ATTRACTIONS: The town of Warm Springs and Hot Springs are nearby, and offer a variety of B & B's, shops, art galleries, restaurants, warm springs, classical music, and a selection of seasonal activities.
